

Eligibility

Works by both amateurs and professionals are eligible. Recent and unshown work at Beaver Brook Association is preferred. This is a non-juried event, but Beaver Brook Association reserves the right to reject any work that is considered to be **inappropriate**.

Categories

Original artwork and photographs depicting "*Natural Wonders*" are preferred, and we welcome contemporary as well as traditional styles. **We will not accept artwork depicting people, man-made structures, domesticated animals, or cultivated plants/flowers.** The accent should be on the local or New England natural environment, but art reflecting a natural theme elsewhere will be considered.

Media

Color or black and white photography; prints and paintings (watercolors, oils, acrylics, pastels, collage and mixed media); indoor and outdoor sculpture in various media. **Please do not submit needlework or craft items.**

Number of Entries & Fees

Three entries maximum per artist in any one or combined media. We will display as many entries as possible. **There is a \$10.00 per artist entry fee.**

Presentation

We will accept art with **light-weight** frames. **We will no longer accept unframed artwork for hanging.** Be aware that the barn is subject to drastic temperature and humidity changes, and prepare your artwork accordingly. All work must be **ready for secure hanging** with either a wire or notched hooks on the back. Size is **limited to 20 x 25 inches**, outside dimensions. Works larger than this will be accepted on a first come, first served basis. Freestanding sculpture must be accompanied by an appropriate mounting stand. **Please attach the title forms (included on the right-hand panel of this brochure) to the back of each piece of your work.**

Delivery of Work

Maple Hill Farm, 117 Ridge Road, Hollis, NH; Friday, September 14, noon-4:00pm; Saturday, September 15, 9:00am-noon; Monday, September 17, 9:00am-noon. **Please respect delivery deadlines.** No work will be accepted after noon on Monday, September 17, regardless of circumstances. Outdoor sculpture must be entered during the regular times, but may be delivered up until 11:00am, Sept. 20, by pre-arrangement. Any special requirements for delivery or display must be discussed in advance.

Sales & Commissions

Art displayed may be sold during the Festival, but may **not** be picked up by the buyer until Sunday, September 30, after 5:00pm. There is a 20% commission to Beaver Brook Association on any sales during the Festival. The proceeds benefit the Beaver Brook's mission of environmental education and land stewardship.

There will be limited artist bin space for display and sale of additional matted prints, if you so choose. The 20% commission applies to these sales and a 50% commission on note card sales as well. If you have a bin that you are willing to share, we would appreciate its use during the Festival.

Pickup of Work

Works should be **signed out** and picked up between 5:00-6:00 pm on September 30. If work cannot be picked up that day, it should be picked up within **two weeks** during regular office hours, Monday - Friday, 9:00am - 4:00pm. **After two weeks, Beaver Brook Association will assess a \$10/week storage fee. After 45 days, Beaver Brook Association will consider any unclaimed artwork as a donation.**
